From the Desk of Rev. Erin Kobs, Transitional General Presbyter

Friends,

I want to take us back to January 2022, which is when the group known as Team Hope began their journey together. For the next 20 months, the team met each month with our consultant Graham Standish thinking & dreaming about how our presbytery could move forward, listening to where God was calling us next. As you may remember, a lot of heart, long hours, & frankly, a lot of chocolate went into preparing a new structure plan that could meet the needs of our presbytery moving forward. In August 2023, Team Hope held listening & feedback sessions across the presbytery, where we were able to share the plan with folks. From those sessions, the team discerned that a first read would happen at the September 2023 Gathering. At our November 2023 Gathering, the Team Hope Plan was officially adopted to take effect in January 2024.

Throughout 2024, our two commissions began to meet & figure out what their main responsibilities would be & asked for the presbytery's approval for various commission powers. The Organization Commission & the Congregation & Pastor Formation Commission worked hard throughout 2024 to meet the needs of the presbytery & help to streamline the efficiency of processes. A lot of hard work happened & positive changes began to be experienced in the presbytery, both in gatherings & in congregations.

In March 2024, a PNC search team was elected to conduct the search for two presbyter positions. This team worked diligently over the coming year to develop job descriptions & all necessary information to begin a search process for the best candidates to search within our presbytery. This spring & early summer, the team interviewed folks interested & narrowed it down to two folks they feel will serve the presbytery well.

This brings us to this Saturday, where the GPS Team will present two candidates before the presbytery, the Rev. Erin Kobs (Organizational Presbyter & Stated Clerk) & the Rev. Dr. Angela Cowser (Training Presbyter). It's been a journey, but this is one of the final pieces of puzzle in our structure! God certainly done with us yet. Hope to see you on Saturday.

There will be a meet & greet beginning at 9:00am to meet with the candidates. The meeting portion of the gathering will commence at 11:00am.

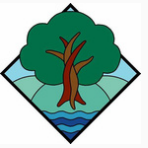
The meeting is hybrid.

Cost: \$10.00 each for Book of Order & \$12.00 each for calendars.

PA Annual Report

Beginning in 2025, churches will need to complete an Annual Report with the state of Pennsylvania in order to maintain their non-profit status & tax-exempt status. **Filing after June 30th, there will be a fee.** Continued non-compliance could result in your church falling out of "good standing" or even administrative dissolution by the state.

- Churches need to update their contact information & report on who their corporate officers are for their "Corporation" (i.e. president, secretary & treasurer)
- The corporate officers must be properly elected by the session (unicameral board) or Trustees (bicameral board) & documented in your minutes. If your church has not elected officers recently, you need to begin the process & duly elect them before filing the Annual Report.

Insurance Reimbursement Fund

Does your church have Guide One Insurance?

The Presbytery has a fund to help reimburse your deductible when you have an insurance claim. This is not just claims from storm damage. If you have a claim, you can send in your information regarding your claim for the Presbytery to review. The reimbursement will be for \$500.00.

Mandated Reporter Trainings

A reminder that the Book of Order does require that elders, ministers, & volunteers (Sunday school teachers, VBS workers, anyone who is working directly with children) every **36 months** (G-3.0106). This is a change from the past, when it was every 5 years, which is still the requirement for the Commonwealth of Pennsylvania.

Mandated Reporter training takes about an hour & a half. There is the option to do Zoom for these. The Zoom link will be emailed to all registered participants on **the day of the training**.

Update from Syria & Lebanon Partnership

It has been an increasingly difficult time for our brothers and sisters in Syria and Lebanon. While the U.S. attacks on the Iranian nuclear program have intensified security and economic concerns, closer to home, Syrians are now facing the fallout of a suicide bombing and shooting attack by an ISIS affiliate on the Mar Elias Greek Orthodox church in Dweila, a suburb of Damascus, that killed 25 worshipers and wounded 63 others. While several NESSL (National Evangelical Synod of Syria & Lebanon) pastors have expressed deep concern as to how these attacks will impact their congregations, churches in the immediate area are working to respond and to provide greater security measures from the government when congregations gather for worship and other activities and request more effective protection from the government. Some are considering the installation of metal detectors for all church events.

Several ministers from the new government of Syria have visited the church and expressed concern while the top Sunni cleric, the Grand Mufti, condemned the attack. More recently, the new government arrested a number of individuals suspected of playing a role in the attack, a departure from its passive response to other acts of violence against civilians, calling them “overreaches” by individuals, thereby refusing to take responsibility. The immediate response from the international community, including the United States, has been to condemn the attack and to show concern for the fate of minorities under the new government.

Our sources say the churches have raised again their concerns over the series of “overreaches,” labeled by the government as individual behavior and isolated incidents for which the government has refused to take responsibility. This has occurred so many times, the churches’ fear is that these isolated incidents have been transformed into “institutionalized systematic practices against Christian communities.” They have reportedly called for the government to break its silence against such attacks because it impacts the dignity of all Christians in the country. Other voices are admitting that bringing the entire country together, with its many diverse groups, under one umbrella of a united Syria will take time.

Statistics show that before the war there were approximately one million Christians in Syria and that now there are fewer than 300,000 due to emigration and flight. The new government is walking a tightrope between the international community’s demands for human rights and the demands of the Islamists that brought it to power.

Deep fear and uncertainty continue to grip our partners and churches in Syria and neighboring Lebanon. We ask your prayers for all of our NESSL churches and the entire region as events unfold

Clearances



- **Mandated Reporter Training** (Child Abuse Prevention) - all ministers, elders, deacons & volunteers who work with children. Certificates are good for 36 months.
- **Boundary Training** - all ministers & elders. Must be done every 36 months (according to the Book of Order)
- **FBI Fingerprint Clearance** - all ministers. Certificates are good for five years (in accordance with PA state law & Presbytery policy)
- **PA State Police Clearance** - all ministers & those who work directly with children. Clearance is good for five years (PA state law), but are highly recommended to be done every 3 years for protection of our churches.
